1. Definitions

In this Agreement:

- 1.1 'Agreement' means this licence document, including all of its terms and conditions as outlined in the Repository Policy (https://www.hud.ac.uk/media/policydocuments/Repository-Policy.pdf), as amended from time to time and associated procedures.
- 1.2 'I' and 'Me' means the user of Work
- 1.2 'Repository' means the University of Huddersfield ePrints Repository
- 1.3 'The University of Huddersfield' and 'University' means University of Huddersfield, Queensgate, Huddersfield, HD1 3DH
- 1.4 'Work' means the e-print being accessed including abstract, text, images and related data.

2. User's declaration

- 2.1 I agree to be bound by the following conditions each time that I use any Work contained within the Repository:
- i. I will ensure that all the requirements of the agreements, contracts and licences under which the Work is held will be maintained. (Copies of the relevant agreements, contracts and licences can be requested by written application to the Repository Administrator, via email (openaccess@hud.ac.uk))
- ii. I agree to indemnify and defend the copyright holder from and against any and all liability and costs incurred in connection with any claim arising out of any breach of this Agreement by Me.
- iii. I will not remove or alter the copyright statement on any copies of the Work used by Me.
- iv. I will ensure the security and confidentiality of any copy released to Me, and will not make any further copies from it or knowingly permit others to do so, unless permitted to do so under this Agreement.
- v. I will only incorporate the Work, or part thereof, in any work, program or article which I produce, where this is permitted by the <u>Repository Policy (https://www.hud.ac.uk/media/policydocuments/Repository-Policy.pdf)</u> and associated procedures or by "fair dealing" (see https://www.gov.uk/quidance/exceptions-to-copyright).
- vi. I will only incorporate some part or version of the Work in any work I produce with the express permission of the licensor or unless this is expressly permitted under this Agreement, the Repository Policy (https://www.hud.ac.uk/media/policydocuments/Repository-Policy.pdf) or associated procedures.

vii. I will not reverse engineer or decompile the software products or attempt to do so unless this is explicitly permitted within the terms of this Agreement for the use of the Work.
